  - President responded to reference Section 6.5 in the PSCC by-laws and letter from PSSC attorney addressing compliance.
- Officer on duty addressed the audience warning of Class B misdemeanor for causing disruptions during the board meeting.
- The board read a letter from the PSCC attorney outlining the Texas Property Code qualifications for residents running for office.
- A resident moves to suspend voting to get clarification on voting qualifications.
  - President clarifies appropriate documentation from PSCC attorney clarifies any questions and voting will continue.
- Motion to move forward with the election. Approved and 2<sup>nd</sup>.
- Voting ballots and absentee voting ballots were collected.
